**Waste Site Permit – Increase 2025**

Numerous break ins and trespassing after hours, at the Ingram Waste Disposal Site, have occurred in 2024. Cutting locks; opening the storage units (removing the contents and spreading around the site); smashing glass; and spreading other debris around the site have caused extra expenses and staff time to maintain the Site.

For the reasons noted above, the Council of the Corporation of the Township of Evanturel has no choice but to increase the Waste Site Permit annual fee to \$100.00, commencing January 1, 2025.

*\*Note this fee increase is in line with other waste disposal sites in the area that charge non-resident user fees.*

The Ingram Waste Disposal Site is governed by Township of Evanturel By-law No. 2014-21 – note the following:

**Section 3 - THAT** any person dumping dead animals or other non-acceptable waste shall be liable to a fine not exceeding \$500, exclusive of costs.

**Section 4 - THAT** no person shall trespass in the Waste Disposal Site area except to unload waste on the days and times the site is open to the public. Any person trespassing during non-operation hours shall be liable to a fine not exceeding \$500, exclusive of costs. **Please be reminded unauthorized salvaging, recycling, and scavenging is prohibited**
